



## Tuition Fees Agreement for 2026-2027

**Toddler/Primary Full Day** \$24,450.00 Includes Material Fee, Year Book, Lunch, and School Deposit  
Pre-School—K 8:30am - 2:30pm.

**Non-Refundable School Deposit** \$1,950.00 Due upon enrollment

**Monthly Tuition** (10-month tuition payment plan) \$ 2,250.00 from July 1, 2026 – April 1, 2027

**Toddler/Primary Half Day** \$19,350.00 Includes Material Fee, Year Book, and School Deposit  
Pre-School—K 8:30am - 11:30pm. (For students 18 months - 4-year-olds only)

**Non-Refundable School Deposit** \$1,900.00 Due upon enrollment

**Monthly Tuition** (10-month tuition payment plan) \$1,745.00 from July 1, 2026 – April 1, 2027

**Elementary Grades** \$26,950.00 Includes Textbooks, Year Book, NESTT, Lunch, and School Deposit  
First grade – Fifth grade 8:30am - 3:30pm.

**Non-Refundable School Deposit** \$2,950.00 Due upon enrollment

**Monthly Tuition** (10 month tuition payment plan) \$2,400.00 from July 1, 2026 – April 1, 2027

Payments are due the first day of the month. I/we understand that payments received after the 5th day of the month are subject to a late charge of \$50.00, and that there will be no exceptions to this rule, including postal delays. \_\_\_\_\_

I/we understand that any cancellations must be submitted in writing **60 days** in advance and must be approved by the School Administrator. Full tuition is due for the 60 day period and no refunds or credits will be issued. All accounts must be settled before transcripts and records can be released. Accounts that are past due over 30 days, will be cause to immediately terminate student enrollment at the school's discretion. \_\_\_\_\_
