Toddler/Primary Full Day \$17,800.00 Includes Material Fee, Lunch, and School Deposit
Pre-School—K 8:30am - 2:30pm.

School Deposit \$950.00 Due upon enrollment

Material Fee \$350.00 Due upon enrollment

Monthly Tuition (10 month tuition payment plan) \$ 1,650.00 from August 1, 2021 – May 1, 2022

Toddler/Primary Half Day \$13,300.00 (material fee and school deposit included)

Pre-School—K 8:30am - 11:30pm. (For PS students 3 and 4 year olds only)

School Deposit \$950.00 Due upon enrollment

Material Fee \$350.00 Due upon enrollment

Monthly Tuition (10 month tuition payment plan) \$1,200.00 from August 1, 2021 – May 1, 2022

Elementary Grades \$19,800.00 Includes Text Books fee, NESTT & STEAM, Lunch, and School Deposit

First grade – Fifth grade 8:30am - 3:30pm.

School Deposit \$1,425.00 Due upon enrollment

Text books & Materials \$875.00 Due upon enrollment

Monthly Tuition (10 month tuition payment plan) \$1,750.00 from August 1, 2021 –May 1, 2022

I/We agree to pay a Deposit Fee payable upon enrollment, and I/we understand this deposit is non-refundable. _____

I/We agree to pay Material fees, NESTT fees and fees for text books, and I/we understand these fees are non-refundable. _____

The remaining balance will be paid in ten (10) monthly payments, commencing on August 1, 2021 and ending May 1, 2022. _____

Payments are due the first day of the month. I/we understand that payments received after the 5th day of the month are subject to a late charge of \$50.00, and that there will be no exceptions to this rule, including postal delays. _____

I/we understand that any cancellations must be submitted in writing 60 days in advance, and must be approved by the School Administrator. All accounts must be settled before transcripts and records can be released. Accounts that are past due over 30 days will be cause to immediately terminate student enrollment at the school's discretion. _____

I/we understand that After School Care will be charged at the rate of \$6.00 per hour for anyone not registered for monthly After School Care. Latecomers will be charged a late fee of \$15.00 _____

I/we understand that there will be no refunds or credit for absences, cancellations, holidays, school breaks, sick days, expulsions or suspensions. _____

A Family enrolling two or more children will receive a discount of 5% on the second child; discounts apply on lowest tuition amount.

I/We give Cattoira Montessori School permission to use my Son/Daughter's likeness or photo that may appear in school publications, TV or electronic media. _____
